SECTION 02235: Page 02235-2, paragraph 2.2.1, after the first sentence insert the following: "Joining system for piping shall be as specified in ASTM A 760 for Corrugated Bands with O-ring gasketing and as recommended by the manufacturer of the piping. Corrugated Bands shall be provided with annular corrugations matching the pipe to fully engage each annular pipe end for 360⁰. Structural properties of the joining system shall conform to the requirements of ASTM A 760, paragraph 9.4."
