C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- The approximately 6.89-acre Thompson Property is identified as Parcel 012-4-01-11B and located at 964 Walker Road in Fairfax County, Virginia. More generally, the Property is located at 38°58'59"N latitude and 77°17'32"W longitude on the Vienna, VA USGS Quadrangle. The Property drains to the northeast towards Captain Hickory Run, which is located within the Difficult Run watershed (PL22) of Hydrologic Unit Code (HUC) 02070008 (Middle Potomac – Catoctin).
- Property boundary, topographic and existing conditions mapping and wetland survey information provided by Urban, Ltd. Survey information is provided at NAD83, Virginia State Plane, North Zone - 4501, NAVD88, US Survey Feet.
- The waters of the U.S. and wetlands at the Property were delineated by BCG on August 24, 2015 based on the requirements of the Corps of Engineers Wetlands Delineation Manual (1987) and the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Eastern Mountains and Piedmont Region (Version 2.0, 2012), and represent those areas that are most likely within the regulatory purview of the USACE. Based on the results of the field investigation, there are no waters of the U.S. or wetlands identified within the Property limits.
- The results of this wetland delineation and absence of jurisdictional areas on the Property should be considered preliminary until approved by the USACE during a Jurisdictional Determination.
