### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.



**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The two isolated wetlands are within a farm field that is planted with soy beans that appeared to be growing well everywhere except for the two wetland areas. The smaller of the two wetlands had standing water and was covered in alligator weed (*Alternanthera philoxeroides* OBL). The larger one was predominantly unvegetated, with areas covered in dried algae, and the eastern side was mostly ponded water. Saturation is visible in both areas on multiple years of aerial imagery. The 1994 DOQQ imagery shows that there used to be a ditch system that ran right through these two spots. This was when the property was still developed with a single family residence and a small saw mill. Once the land was converted to farmland it has been under cultivation since. The area has been manipulated enough to where any connection to jurisdictional waters that may have existed are no longer there. These two wetland pockets no longer have a surface connection to jurisdictional waters and are therefore considered isolated and not within the Corps jurisdiction. .


