#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. **B. ADDITIONAL COMMENTS TO SUPPORT JD:** The 0.254 acre review area was investigated by the consultant on June 1, 2018 reviewing the parcel for hydrophytic vegetation, hydrology, and the presence of hydric soils. The undeveloped lot is mainted by regular mowing, no primaryhydrology indicators were observed but the site met one secondary hydrology indicator (dry season water table). Dominant vegetation included FACU and UPL species bulbous wood rush, flatweed, and common cinquefoil. Native soil was below 29" of fill material, likely placed over 30 years ago, the fill material displayed redox features. Native soil met the Thick Dark Surface hydric soil indicator. This parcel only met one of the three wetland factors (soil), therefore the entire 0.254 acre parcel consists of uplands.
