### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** In WSSI's opinion, the three PEM wetlands delineated in the northeast, northwest, and southwest portions of the site are isolated water bodies as they appear to lack a significant nexus with jurisdictional waters of the United States. Based on decisions in the U.S. Court of Appeals for the Fourth Circuit and the U.S. Supreme Court and related guidance issued by the U.S. Army Corps of Engineers (COE) on May 29, 1998, the COE is not regulating isolated water bodies at the present time, unless the COE determines that there is a connection with interstate commerce or that the isolated water body is adjacent to a jurisdictional water of the U.S. The Corps concurred with WSSI at the time of the site visit 04/10/18. The three isolated wetlands are not jurisdictional under the Clean Water Act.
