C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Findings for: NAO-2008-1640 WOUS

The RPW with "seasonal" flow in combination with its adjacent wetlands have the capacity to carry and reduce the amount of pollutants, transfer, breakdown, and removal of nutrients and organic compounds, and support aquatic / wildlife habitat and ecology. The tributary provides water storage and reduces flooding. The stream also serves to and increase water quality of storm water run off from agricultural fields and residential sites, thus reducing the amounts of pollutants from reaching the TNW. The stream contributes to and supports commerce in the TNW.
