Section 408 Categorical Permission 1 (408-CP-01) Review Request Form

To be completed by the Section 408 Requester:

U.S. Army Corps of Engineers, Norfolk District (USACE) Section 408 Categorical Permission 1 (408-CP-01) grants permission to alter specific Civil Works Federal Navigation Projects located in the Middle Peninsula of Virginia and covers any approved alteration¹ to conduct maintenance dredging and dredged material placement activities within the designated Federal Navigation Project framework <u>and</u> in conjunction with a Department of the Army (DA) permit verification or authorization. This Categorical Permission (CP) was issued pursuant to requirements set forth in Engineer Circular (EC) 1165-2-220, *Policy and Procedural Guidance for Processing Requests to Alter US Army Corps of Engineers Civil Works Projects Pursuant to 33 USC 408*, 10 September 2018, Appendix C.

The designated USACE Civil Works Federal Navigation Projects covered by 408-CP-01 are listed below and included on the maps depicted on the document titled "Section408_Categorical_Permission1_CW_Project_Maps.pdf" which can be found on the Norfolk District Section 408 webpage: https://www.nao.usace.army.mil/408Review/. The referenced project maps indicate each Federal Navigation Project included in this CP, the non-federal sponsor for the USACE Civil Works project, distance to USACE designated placement site if applicable, geo-referenced channel framework, setback distance from the Federal Navigation Project indicating boundary for which Section 408 authority applies, and authorized dimensions.

To initiate a 408-CP-01 verification review request, the Section 408 Requester (Requester) must fully complete this CP Review Request Form², below, including the requested information in Section A, confirmation of compliance with the terms and conditions of 408-CP-01 in Section B, additional information in Section C, and provide a final signature certifying that the information provided is complete and accurate.

DISQUALIFYING CIRCUMSTANCES:

The following conditions would disqualify the use of 408-CP-01:

- 1. The alteration does not require a Department of the Army permit authorization or verification from the Norfolk District Regulatory Branch.
- 2. The alteration could not be decided at the District level.
- 3. The alteration would remove riparian or sensitive habitat.
- 4. The alteration would adversely impact a public use facility.
- 5. The alteration would require an Environmental Assessment (EA) or Environmental Impact Statement (EIS) outside the scope already addressed in this CP and in the DA permit decision document.

¹ "Alteration" refers to any action by any entity other than USACE that builds upon, alters, improves, moves, obstructs, or occupies an existing USACE project. Unless otherwise stated, for ease of reference, the use of the term "alteration" in this document also includes "occupation" and "use."

² Note: The following form is intended for application purposes only and includes information that USACE reviewers require when considering a Section 408 request for under this CP. Completion of this form does not grant Section 408 permission, but only serves to initiate a verification review under the CP. The Section 408 permission is not granted until the USACE reviewer has confirmed compliance with the CP and provided a final written Section 408 permission letter.

2. The Requester confirms the proposed maintenance dredging will not exceed the authorized dimensions of the Federal Navigation Project (depth or width). This does not include any paid allowable overdepth dredging as described in this CP.

The Requester agrees that if the alteration activities interfere with marine traffic in the Federal Navigation Channel, the Requester will coordinate all activities with the US Coast Guard Sector Virginia (USCG) at VirginiaWaterways@uscg.mil or (757) 668-5580 a minimum of 45 days prior to commencement of work, so that those activities that may impact navigation can be included in the Local Notice to Mariners.

9. The Requester agrees that if the alteration activities require the USCG to temporarily or permanently relocate any Aids to Navigation (ATONs) to facilitate maintenance dredging activities, the Requester will coordinate those activities with the USCG Sector Virginia at VirginiaWaterways@uscg.mil or (757) 668-5580 a minimum of 45 days prior to commencement of work, so that the USCG is allowed adequate time to coordinate resources egied to relocate ATONs.

10. The Requester must ensure that its contractor performs all work in such a manner that its dredge plant and associated equipment encroaches or obstructs the Federal Navigation Channel to the minimum extent possible. If the contractor's dredge plant or equipment does obstruct the channel and makes it difficult for or endangers the safe passage of vessels, said dredge plant must be promptly moved on the approach of any vessel to such an extent as may be necessary to afford a safe passage.
