The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:





WATERS OF THE U.S. DELINEATION AND SURVEY NOTES:

1. Wetland Studies and Solutions, Inc.'s (WSSI) wetland flagging and data point location was located in the field by Gordon on July 21, 2015.

2. Periodic flag numbers are shown depicting the survey-located boundary of wetlands and other waters of the U.S. (i.e., stream). Waters of the U.S. flags are pink-glo in color. The data point is flagged with orange-glo and pink-glo flagging tied together.

3. Topo/boundary information obtained in digital format from Arlington County digital data was used as a base for this Attachment.

4. This delineation was performed pursuant to the "Corps of Engineers Wetlands Delineation Manual," Technical Report Y-87-1 (1987 Manual) and subsequent guidance and modification by the Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Eastern Mountains and Piedmont Region (Version 2.0), dated April 2012.

5. The Routine On-Site Wetland Determination Method for sites less than 5 acres was used.

6. Field work was performed on July 16, 2015 by Lauren Shaffer, W.P.I.T., CT.

7. This water of the U.S. (i.e., stream) outside of the study area, upslope. 8. This water of the U.S. (i.e., stream) outside of the study area, downslope.

9. While swales labeled "DRYLAND SWALE (NOTE #9)" possess short segments of defined channel with evidence of flow (i.e., drift lines of debris), they lack hydric soils and continuous ordinary high water marks and terminate in uplands, thereby lacking a jurisdictional connection with waters of the U.S. Therefore, in WSSI's opinion, these swales are not jurisdictional waters of the U.S. (subject to COE concurrence).


10. Stream evaluation methods developed by the North Carolina Division of Water Quality (NCDWQ) and the Fairfax County Department of Public Works and Environmental Services (DPWES) were used in the field to distinguish between ephemeral and intermittent streams (based on the NCDWQ method) and between intermittent and perennial streams (based on both methods). These methods were used to characterize representative reaches of the streams on and within 100 feet of the study area.

11. The term "Perennial" used on this Attachment classify and describe the flow regime character of streams, are based on WSSI's field observations, and are only provided for state and local regulatory purposes. The flow regimes of streams are not verified by the COE; however, the geographic limits of these streams are all subject to COE jurisdiction, and the COE's approval of this delineation represents only the approval of the geographic limits of waters of the U.S.

12. The limits of the Resource Protection Area (RPA) depicted on this Attachment are based on the surveyed location of the perennial water bodies and jurisdictional wetlands that are RPA core components. The RPA extends 100 feet landward of the RPA core components or to the extent of the steep slopes, whichever is greater. Steep slopes do not extend past the 100-foot buffer within the study area. Note that Arlington County requires the submission of an RPA Delineation Plan if any portion of the property is located within an RPA, in conjunction with any proposed land disturbance exceeding two thousand five hundred (2,500) square feet (Arlington County Code, §61-13.B).

13. The remainder of the study area is designated as a Resource Management Area (RMA), as are all areas of the County not included as an

14. WSSI has delineated and surveyed western side of the stream along the eastern boundary in order to accurately determine the location of the RPA. The eastern side of the stream is shown approximately, as it does not affect the RPA within the study area.
