The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: There is a constructed ditch (a feature with no ordinary high water mark) along the southern boundary of the wetland. The bottom of the ditch appears to be several feet lower than the surface of the wetland. On 3-22-2018, water was flowing within the limits of the ditch, however, the entire length of ditch adjacent to the wetland was examined, with no

observance of water directly flowing from the wetland to the ditch. Observation at the lower end (beyond the limits of the wetland) showed that water volume and flow rate appeared to be similar to the ditch upstream of the wetland. Thus, the ditch did not appear to be gaining additional water from the wetland. There are no other waterbodies, conveyances, tributaries present which would serve as a connection to downstream waters of the U.S. This observation supports the findings that the wetland is isolated and not connected to interstate waters..
