B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The terrain of the project site consists of gently sloping, wooded and unimproved land. The property occurs within the Lower Aquia Creek drainage basin and drains north east (*Appendix I: Figure 2- USGS Topographic Map*). The site is currently zoned-B2-B2 GENL COMMERCIAL. Surrounding land use is residential to the west, commercial to the south, undeveloped to the north, and institutional (St. William of York Catholic Church) to the east. Based on our field reconnaissance, there are no streams or wetlands onsite.
