C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Other: (explain, if not covered above): **The consultant mapped 5 pockets of isolated wetlands in the farm field in the middle of the project area. None of these wetlands has a surface connection to any of the jurisdictional ditches. A review of Google Earth Pro aerial photographs dated 5/2/2018, 11/5/2016, 4/23/2014, 8/27/2011, and 1/31/2011 show darker signatures in years 2014 and 2011. Even in 2011 and 2014, the wetlands do not appear to have surface connections to the RPWs (ditches). These wetlands appear to be transient features, variable in size and shape and completely absent in some years. Ground photos taken on March 18, 2020 showed no standing water in some of these isolated wetlands, and later on April 28, 2020 some of these same areas held several inches of standing water.**
