Summarize overall biological, chemical and physical functions being performed: Wetlands are filtering run off from upland areas prior to entering the RPW's that flow directly to a TNW. The vegetation filters larger pollutants such as trash and debris. Water soluble pollutants enter the soil and then interact with the minerals that allow organic pollutants as well as nitrogen and phosphorus to remain in the soil and not enter the RPW/TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Jurisdictional Impoundments were dug from an existing tributary that flowed directly into a TNW. Historically this Tributary was a main drainage easement for the city of Chesapeake. As development increased surrounding this easement, it was decided to create a series of impoundments to slow the amount of sediment and debris being carried by this tributary directly into the Elizabeth River (TNW).
