C. Additional comments to support AJD: Blue Ridge weather station for July 2020 (delineation complete date) showed precipitation to be at or below normal for the month and the same for the year. Site visit showed a disturbed site and staff on site verified the site had been manipulated over the years. There was no sign of any hydrophytic vegetation or standing water on site. The majority of the site was on a hill side slope.
