area. The open grass fields had no indicators of hydrology and contained *Digitaria sanguinalis* & *Cynodon dactylon* which are FACU indicative of non-wetland grassed fields. During the site investigations, no potential wetland areas were identified. Swales in the 5.5acre Edwin Drive and Edinburgh Lane Right-of-Way had no ordinary high water marks, no surface water connection, no flow, and no connection to upstream wetlands or other waters of the U.S.
