- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Ponds C, D, F, and G were evaluated on-site to determine if they were jurisdictional. According to the agent, these are acting as stormwater ponds. Also, according to a topo map search, these four ponds were all excavated out of uplands between 1985-1990 instead of being impounded jurisdictional waters. The non-jurisdictional ponds total approximately 4.03 acres.**

PSS wetlands marked "A" are part of a jurisdictional impoundment and are jurisdictional. Ponds B and E, labeled as "palustrine unconsolidated bottom" or PUB features, are also impoundments of a tributary to the Nansemond River. The limits of jurisdiction are considered to be the normal pool elevation of the ponds.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

The Corps used historic topo maps to determine that impoundments E and B were connected and are impoundments of a tributary that was called Pitchkill Creek. The 1919 and 1949 Smithfield maps shows a tributary with adjacent wetlands that flows into the Nansemond River, which is a Section 10 water. The 1965 map shows a single impoundment of this same tributary with a stream and wetlands below the dam.
