### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

- Other: (explain, if not covered above): **The review area contains ~2.62 acres of non-tidal wetlands that are isolated and have no surface water connection to waters of the U.S. These are small, depressional, PEM wetlands that have been continuously mowed for decades and are thought to have been formed from historic mining on the property (depicted on historic USGS quads). The U.S. v. Wilson (4th Cir. 1997) decision effectively removed isolated wetlands and other waters from CWA jurisdiction in the 4th Circuit. There is also an isolated, manmade stormwater BMP feature (~0.47 acres) that was constructed for stormwater management within a maintained field and is still used for stormwater management.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** U.S. v. Wilson (4th Cir. 1997) court decision resulted in neither the Corps nor the EPA relying upon or citing 33 C.F.R. 328.3(a)(3) as the basis for asserting Clean Water Act jurisdiction over isolated waters in the Fourth Circuit. Isolated wetlands/waters (areas that lack a surface connection to downstream waters) are NOT regulated by the Norfolk District but may be regulated by the Virginia Department of Environmental Quality (DEQ).
